

PRIVACY POLICY

This Privacy Policy ("Policy") applies to the website owned and operated by Trips4Trade, LLC ("Company," "we," or "us") located at www.trips4trade.com (the "Site"). The Policy is designed to tell you how we collect and use personal information (as defined below) so you can make an informed decision about using the Site. Please read this Policy before using the Site or submitting any personal information to us or to the Site. We reserve the right to change the provisions of this Policy at any time by posting a revised Policy on the Site and indicating on the Policy the date it was last updated. Your use of the Site following the posting of such changes or revised statement shall constitute your acceptance of any such changes. We encourage you to review our Policy whenever you visit the Site to determine if any changes have been made and to make sure that you understand how any personal information you provide will be used.

Personal Information

When you register on the Site, you will be asked to enter your name, email address, mailing address, phone number, and payment information and choose a username. Your username is publicly displayed and connected to your activity on the Site. Other people may see the date you joined; ratings, reviews and related photos for items or services that you traded; your profile information; items or services you listed for trade; your favorites, followers and those you follow; traded item or service listings and the number of items or services traded; and comments you post in our community spaces. You may optionally choose to provide and publicly display your full name and other personal information (such as birthday, gender, and location).

We do not sell, share, or rent any personal information to others in ways different from what is disclosed in this Policy without first obtaining your consent, although we may provide aggregate information or other nonpersonal information to third parties without your authorization. We may share your contact information with third parties if you have indicated to us that you wish to receive information from such parties. In the event that we engage or partner with third party vendors, consultants, or other service providers in connection with the operation of the Site and our business ("Service Providers"), we may share personal information with such Service Providers who need access to such information to carry out their work for us.

You should also note that information that you post to the Site, may become publicly available. Your posting to the Site constitutes your consent to share such information publicly.

We also may disclose personal information when we are required to or we believe it is appropriate to comply with the law (e.g., a lawful subpoena, warrant, or court order); to enforce or apply this Policy or our other policies or agreements; to initiate, render, bill, and collect for amounts owed to us; to protect our or our users' or our rights, property, or safety; to protect our customers our us from fraudulent, abusive, or unlawful use of our Site; or if we believe that an emergency involving the danger of death or serious physical injury to any person requires disclosure of communications or justifies disclosure of personal information. In addition, information about our customers, including personal information, may be disclosed as part of any merger, acquisition, debt financing, sale of company assets, as well as in the event of an

insolvency, bankruptcy or receivership in which personally identifiable information could be transferred to third parties as one of the business assets of the Company.

Email

We will use e-mail to send you news and service updates, as well as notification of messages from other users unless you "opt out" to receiving such e-mails by using the unsubscribe links within the e-mails that we send. Please note, however, that as long as you maintain an account, you may not "opt out" of receiving service or account-related e-mails from the Company.

Cookies

A cookie is a small amount of data, which often includes an anonymous unique identifier, which is sent to your browser from a web site's computers and stored on your computer's hard drive. Cookies are required to use the Trips4Trade service. We may use cookies to record current session information, but do not use permanent cookies. You are required to log-in to your Trips4Trade account after a certain period of time has elapsed to protect you against others inadvertently accessing your account.

Data Storage

Trips4Trade uses third party vendors and hosting partners to provide the necessary hardware, software, networking, storage, and related technology required to run Trips4Trade. Although Trips4Trade owns the code, databases, and all rights to the Trips4Trade application, you retain all rights to your data.

Security

The Company endeavors to secure your personal information from unauthorized access, use, or disclosure by putting into place physical, electronic, and managerial procedures to safeguard the information we collect through this Site. Additionally, your account information is accessible online only through the use of a password. Please be aware, however, that despite our efforts, no security measures are perfect or impenetrable. To protect the confidentiality of your personal information, you must keep your password confidential and not disclose it to any other person. You are responsible for all uses of the Site by any person using your password. Please advise us immediately by emailing us at info@trips4trade.com if you believe your password has been misused or disclosed to anyone other than yourself. You should also note that e-mail is not secure, and you should not send any confidential or sensitive information to us via an unsecured e-mail.

We cannot protect, nor does this Privacy Policy apply to, any information that you transmit to other users. You should never transmit personal or identifying information to other users.

Children

The Trips4Trade service is not intended for individuals under 19, and we do not knowingly collect information from individuals under the age of 19.

Individuals age 13 to 18 should not submit any personal information without the permission of their parents or guardians. By using the Trips4Trade service, you are representing that you are at least 19, or that you are at least 13 years old and have your parents' permission to use the service.

Changes

Trips4Trade may periodically update this policy. We will notify you about significant changes in the way we treat personal information by sending a notice to the email address specified in your Trips4Trade primary account holder account or by placing a prominent notice on our site or blog.

International Users

By accessing Trips4Trade or providing data to us, you agree we may use and disclose data we collect as described here or as communicated to you, transmit it outside your resident jurisdiction, and store it on servers in the United States.
